The Law Society successfully promoted Hong Kong's legal system and services to the Forum participants from the international legal and business communities, including Consulates-General and overseas chambers of commerce in Hong Kong, as well as legal professionals and businessmen from diverse jurisdictions, which had enhanced their understanding of Hong Kong's robust legal system and business environment, and hence bolstered their confidence in Hong Kong's long-term economic development and competitiveness in the rapidly changing world.

### **3.5 Overall achievements of the project**

The Forum was successfully concluded with over 1 800 participants from 31 jurisdictions, including the physical attendance of more than 50 representatives from Consulate-Generals and overseas chambers of commerce.

Through open, frank, fact-based discussions and exchange among government officials, business representatives, as well as experts and scholars from the legal sector across the world, the Forum facilitated insightful exchange of experiences and ideas that can strengthen Hong Kong's status as a leading international legal and financial hub and a gateway to the Mainland for doing international businesses in the post-pandemic era.

All in all, the project provided an excellent platform for information exchange and business opportunities for the participants particularly for the local legal practitioners. As a result, it enhanced the standards and external competitiveness of Hong Kong's legal profession and services in the international legal arena.
